Right to Elect


Elections 2016 (elections to State Duma)

Results:

- According to Russian Election Committee, 5.5 thousand complaints on election irregularities had been registered.
- In 9 districts the results were annulled.
- 32 criminal investigations were initiated (against 54 initiated criminal cases after 2011).

ECHR decision dated 30 May 2017, case ECHR Davydov and Others v. Russia

Freedom of Speech

Harsh laws:

Insulting religious sentiment among believers

Hate speech

Rehabilitation of Nazism (not the same as Holocaust denial)

Insulting religious sentiment among believers

Leading cases:

- Woman firing a cigarette from the church candle
- Man catching Pokemon in a church
- "Matilda"



Hate speech

Article 282 Russian Criminal Code:

- incitement of hatred and enmity, as well as the humiliation of a person or a group on the basis of gender, race, nationality, language, origin, religion, or because a person belongs to a social group
- Punishment: up to 5 years of imprisonment
- Widely used article (in 2010 650 crimes registered, in 2015 - 1186)
- Awkward enforcement: police, football fans, and authorities were considered as forming a social group deserving protection



 "Sharing" or "liking" on social media is enough for inciting hatred



Breaking Territorial Integrity

Article 280.1 Russian Criminal Code


- Calls to violate Russian territorial integrity
- Adopted in 2014 (after Crimean accession)
- Does not mention any recourse to violence
- Imprisonment up to 4 years



Ilmi Umerov was sentenced to 2 years of imprisonment in September 2017

Rehabilitation of Nazism

2 September 2016 the Russian Supreme Court issued a guilty verdict for a statement: "Communists and Germany jointly attacked Poland and started the Second World War; thus, the communism and the nazism collaborated"

Meeting 26 March 2017

In Moscow, more than 20 thousand people went to the street Tverskaya

Around 1 thousand got arrested for taking part in the meeting

Memorial represented Memorial represented 212 people who were prosecuted for taking part in the demonstration. A complaint in relation to 12 people submitted to ECHR.


Meeting 12 June 2017 - around 800 arrested in Moscow and 1800 in Russia

Meeting 7 October 2017 - circa 2 in Moscow and 300 in Russia

80 NGOs are in the list of foreign agents, like Memorial, Golos, Levada center




Political Prosecutions
