




# List of Individuals Recognised as Political Prisoners by **MEMORIAL** Human Rights Centre

and Persecuted in connection with the Realisation of Their Right to  
Freedom of Religion

9 NOVEMBER 2021



By the term 'political prisoner' we mean both those serving custodial sentences and those who have been remanded in custody or placed under house arrest before trial.

We include those prosecuted for exercising their legal rights as well as those who have been unlawfully, or manifestly disproportionately, prosecuted for political reasons by the authorities. We do not include those who have used violence against persons or have called for violence on grounds of religion, nationality, ethnicity, and so on. There are 340 names on this list.

At present, these are predominantly Muslims, mostly charged with membership in the banned organisations Hizb ut-Tahrir al-Islami and Tablighi Jamaat, as well as Muslims accused of membership in the probably non-existent organisation At-Takfir wa al-Hijra. The Jehovah's Witnesses has been another major group of victims of religious persecution, whose organisations were unjustifiably declared extremist and banned in 2017.

Those recognised as political prisoners include 205 individuals prosecuted on charges of membership in the banned Hizb ut-Tahrir al-Islami and 104 prosecuted on charges of affiliation with communities of Jehovah's Witnesses.

This list is manifestly incomplete. It contains only those people and cases for which we have been able to collect and analyze sufficient information to draw a reasoned conclusion about the politically motivated and unlawful nature of the criminal prosecution. The list does not yet include the names of many individuals whose prosecution contains evidence of being unlawful and politically motivated, for the reason that we have either not yet received, or are still analyzing, the necessary information about these cases. The total number of people prosecuted in similar cases is at least three to four times higher than those contained in the list.



We can assume the motives behind the repressive measures against the Muslims on this list include the need for propaganda justifying the reality of the terrorist threat and demonstrating the fight against international terrorism; the suppression of independent associations, even though they do not present a real danger to the public (something practised not only against religious groups); and the corporate interests (in terms of crime statistics) of the relevant law enforcement agencies. In some cases, such as the prosecution in Bashkortostan of human rights defender Rustem Latypov and activist Linar Vakhitov, and in Crimea of human rights defenders Emir-Usein Kuku and Server Mustafayev, the motive, it can be assumed, is also to end the legitimate activities of the victims of prosecution.

The prosecution of residents of Crimea on charges of membership in Hizb ut-Tahrir, of which there are 68 cases in our list, should be highlighted because this organisation is legal in Ukraine and the prosecution of real and alleged members in Crimea is itself an additional tool of intimidation against the Crimean Tatar population and a means to suppress civic activity.

The tightening of legislation and law enforcement practice has resulted in a large number of cases in which charges related to Hizb ut-Tahrir are now prosecuted under Article 205.5 of the Russian Criminal Code ('Organisation of activities of a terrorist organisation and participation in the activities of such an organisation'), which provides for sentences up to life imprisonment, and simultaneously under Article 278 of the Russian Criminal Code ('Preparation for the violent seizure of power'), which provides for sentences of up to 10 years' imprisonment. The sentences handed down by the courts are also becoming longer. The prosecution of Muslims on charges of membership in Hizb ut-Tahrir has been analyzed in detail in a 2018 [report](#) by Memorial's Programme for the Support of Political Prisoners.

The rapid growth in the number of political prisoners in this list continues, in part



because of the mass repression of Jehovah's Witnesses. In the spring of 2018, searches and arrests began in various regions of the Russian Federation affecting dozens of Jehovah's Witnesses, many of whom subsequently became defendants in criminal cases and were remanded in custody. Thirty-five Jehovah's Witnesses are currently serving prison terms and a further 16 have already served their sentences.

This list also includes 15 Muslims convicted in 2016 on charges of preparing the bombing of the Kirghizia Cinema in Moscow and nine Muslims convicted in 2019 on charges of preparing an explosion in the St. Petersburg metro. We believe all these individuals were victims of unproven charges based on fabricated evidence because of their religious affiliation.



# Individuals persecuted in connection with the activities of At-Takfir wa al-Hijra

- 1. Akhtakhanov, Tagir Tapayevich**, was born on 1 March 1980. A resident of the village of Achkhoy-Martan of the Achkhoy-Martan district of Chechnya. He is single and completed secondary education. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Akhtakhanov has been held in custody since 27 November 2013.
- 2. Balakadashev, Inyal Ibragimovich**, was born on 12 August 1987. Legally, a resident of the village of Kaladzhukh of the Dokuzpar district of the Republic of Dagestan, he actually lived in the city of Petropavlovsk-Kamchatsky in Kamchatsky Krai. He is married and completed secondary education. Prior to his arrest, he worked as a sailor. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Balakadashev has been held in custody since 27 November 2013.
- 3. Balakadashev, Nurmagomed Ibragimovich**, was born on 8 July 1983. Legally, a resident of the village of Kaladzhukh of the Dokuzpar district of the Republic of Dagestan, he actually lived in the city of Moscow. He is married with a child and completed secondary education. Prior to his arrest, he worked as a shipping agent. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group') of the Russian Criminal Code for allegedly plotting a terrorist attack in the



Moscow “Kirgizia” cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Balakadashev has been held in custody since 27 November 2013.

- 4. Cheprasov, Sergei Sergeevich**, was born on 10 June 1990. Legally, a resident of the village of Sukhaya Olshanka of the Chernyanka district of Belgorod Oblast, he lived in the city of Moscow. He is single and completed professionalised secondary education. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point ‘a’ (‘Preparation of a terrorist act to be committed by an organised group’), Article 222, Part 3 (‘Storage of arms by an organised group’), Article 223, Part 3 (‘Manufacturing of arms by an organised group’) of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow “Kirgizia” cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Cheprasov has been held in custody since 27 November 2013.
- 5. Esmurzayev, Khoso Gashimovich**, was born on 27 August 1976. Legally, a resident of the village of Zyazikov-Yurt of the Maglobek district of Ingushetia, he lived in the city of Moscow. He completed secondary education and is single. Prior to his arrest, he worked as a taxi driver. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point ‘a’ (‘Preparation of a terrorist act to be committed by an organised group’), Article 222, Part 3 (‘Storage of arms by an organised group’), Article 223, Part 3 (‘Manufacturing of arms by an organised group’) of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow “Kirgizia” cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Esmurzayev has been held in custody since 27 November 2013.
- 6. Fataliev, Shamil Kamilyevich**, was born on 1 October 1968. A resident of the city of Saint Petersburg. He completed a specialised secondary education. He has two underage children. Prior to his arrest, he worked as a carpenter and a fitter. He was sentenced to 7 years of imprisonment in a general-regime penal colony under Article 282.2, Part 1 (‘Organisation of the activities of an extremist organisation’) for his alleged membership of the banned organisation of At-Takfir wa al-Hijra. He has been held in custody since 24 May 2017.
- 7. Makhmudov, Tazhib Taimirovich**, was born on 4 May 1982. A resident of the city of Moscow. He completed secondary education and is married with two children. Prior to his arrest, he worked as a driver. He was sentenced to 13 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point ‘a’ (‘Preparation of a



terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Makhmudov has been held in custody since 27 November 2013.

8. **Maslakov, Artur Konstantinovich**, was born on 2 July 1983. A resident of the city of Moscow. He is single and has an incomplete secondary education. Prior to his arrest, he was not officially employed. He was sentenced to 12 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Maslakov was held in custody from 27 November 2013 to October 2020, when he was released due to his poor health. In August 2021, he was taken into custody once again.
9. **Nasimova, Matlyuba Islomovna**, was born on 30 July 1960. Legally, a resident of the city of Samarqand of the Republic of Uzbekistan and an Uzbekistani national, she lived in the city of Moscow. She holds an incomplete higher education degree from the Samarqand University. She is married with eight children, two of them being underage. Prior to her arrest, she worked as a housemaid and sublet places in a flat that she rented. She was sentenced to 11 years of imprisonment in a general-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mrs. Nasimova has been held in custody since 27 November 2013.
10. **Ramazanov, Islam Magamedkerimovich**, was born on 24 September 1984. Legally, a resident of the city of Derbent in Dagestan, he lived in Moscow. He completed secondary education and is single. Prior to his arrest, he worked as a driver. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised

group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Ramazanov has been held in custody since 27 November 2013.

- 11. Saraliev, Ersmak Shagidovich**, was born on 26 March 1959. Legally a resident of the urban community of Komsomolsky of the Chernozemelsky district of the Republic of Kalmykia. He is single. He completed secondary education and he was an entrepreneur. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Saraliyev has been held in custody since 8 December 2013.
- 12. Shavkhalov, Adam Akhmedovich**, was born on 3 April 1981. Legally, a resident of the village of Zyazikov-Yurt of the Maglobek district of Ingushetia, he lived in the city of Moscow. He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point 'a' ('Preparation of a terrorist act to be committed by an organised group'), Article 222, Part 3 ('Storage of arms by an organised group'), Article 223, Part 3 ('Manufacturing of arms by an organised group'), Article 222, Part 1 ('Storage of arms') of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow "Kirgizia" cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Criminal Code for allegedly plotting a terrorist attack in the Moscow “Kirgizia” cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. Mr. Suleimanov has been held in custody since 27 November 2013.

He was sentenced to 11 years of imprisonment in a strict-regime penal colony under Article 30, Part 1, in conjunction with Article 205, Part 2, Point ‘a’ (‘Preparation of a terrorist act to be committed by an organised group’), Article 222, Part 3 (‘Storage of arms by an organised group’), Article 223, Part 3 (‘Manufacturing of arms by an organised group’), Article 222, Part 1 (‘Storage of arms’) of the Russian Criminal Code for allegedly plotting a terrorist attack in the Moscow “Kirgizia” cinema as an alleged member of the banned organisation of At-Takfir wa al-Hijra. # Convicted on charges relating to 2017 Saint Petersburg metro bombing

- 1. Ergashev, Bakhrom Khasilovich**, was born on 4 October 1978, a citizen of Kyrgyzstan, a resident of the city of Saint Petersburg. He is married with three children. He completed secondary education and worked as a construction worker. He was sentenced to 18 years and 11 months in a strict-regime penal colony and a fine of 500 000 roubles under Article 205.4 Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3, Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30, Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article 223.1, Part 3 ('Illegal manufacture or repair of firearms committed by an organised group'), Article 222.1, Part 3 ('Illegal acquisition and storage of explosives, committed by an organised group'). Mr. Ergashev has been held in custody since 6 April 2017.
- 2. Ermatov, Ibragimzhon Bakhodirovich**, was born on 7 September 1993, a citizen of Kyrgyzstan, a resident of the city of Saint Petersburg. He is single. He completed secondary education and worked as a construction worker. He was sentenced to 26 years and 11 months in a strict-regime penal colony and a fine of 600 000 roubles under Article 205.4, Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3, Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30, Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article 223.1, Part 3 ('Illegal manufacture or repair of firearms committed by an organised group'), Article 222.1, Part 3 ('Illegal acquisition and storage of explosives, committed by an organised group'). Mr. Ermatov has been held in custody since 6 April 2017.

He completed secondary education and, prior to his arrest, worked as a construction worker. He was sentenced to 27 years and 11 months

in a strict-regime penal colony and a fine of 700 000 roubles under Article 205.4, Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205.1, Part 1 ('Contributing to terrorist activity') Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3, Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30, Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article 223.1, Part 3 ('Illegal manufacture or repair of firearms committed by an organised group'), Article 222.1, Part 3 ('Illegal acquisition and storage of explosives, committed by an organised group'). She was sentenced to 19 years and 11 months in a general regime penal colony and a fine of 500 000 roubles under Article 205.4 Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3 Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30 Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article 223.1, Part 3 ('Illegal manufacture or repair of firearms committed by an organised group'), Article 222.1, Part 3 ('Illegal acquisition and storage of explosives, committed by an organised group'). Ms. Karimova has been held in custody since 6 April 2017.
5. **Khakimov, Saifilla Vakhitovich**, was born on 7 July 1978, a citizen of Kyrgyzstan, a resident of the city of Saint Petersburg. He is married with three underage children. He was sentenced to 18 years and 11 months in a strict-regime penal colony and a fine of 500 000 roubles under Article 205.4, Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3, Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30, Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article

He was sentenced to 19 years and 11 months in a strict-regime penal colony and a fine of 500 000 roubles under Article 205.4 Part 2 of the Russian Criminal Code ('Participating in a terrorist association'), Article 205, Part 3, Point 'b' ('Terrorist act committed by an organised group which involves the intentional infliction of death on a person'), Article 30, Part 3 in conjunction with Article 205, Part 3 Point 'b' ('Attempted terrorist attack that would entail the intentional infliction of death on a person'), Article 30, Part 1 in conjunction with Article 205, Part 3, Point 'b' ('Preparation of a terrorist act that would entail the intentional infliction of death on a person'), Article 223.1, Part 3 ('Illegal manufacture or repair of firearms committed by an organised group'), Article 222.1, Part 3 ('Illegal acquisition and storage of explosives, committed by an organised group'). In 2015 he was given a suspended sentence of 2 years of imprisonment under Article 282, Part 1 ('Incitement of hatred') of the Russian Criminal Code. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 27 August 2020.
- 74. Savelyev, Yuri Prokopyevich**, was born on 1 January 1954. A resident of the city of Novosibirsk. He was sentenced to 6 years of imprisonment in a general-regime penal colony under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 9 November 2018.

- 75. Seidkuliev, Rustam Atayevich**, was born in 1977. A resident of the city of Adler in Krasnodar Krai, he is a trowel man. He was sentenced to 2 years and 4 months of imprisonment in a general-regime penal colony followed by 1 year of restricted freedom under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 15 February 2020. From 22 February to 25 September 2020, he was under house arrest, afterwards he was under a ban on certain actions. On 20 May 2021, he was taken into custody.
- 76. Serebryakov, Aleksandr Georgievich**, was born in 1977. He resides in the city of Moscow. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 10 February 2021.
- 77. Shatalov, Sergei Grigoryevich**, was born in 1969. He resides in the city of Moscow. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 24 November 2020. He has been held under house arrest since 26 November 2020.
- 78. Shidlovsky, Oleg Grigoryevich**, was born in 1969. A resident of the town of Gukovo in Rostov Oblast, he is a Physical Education teacher. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 8 August 2020.
- 79. Shmidt, Igor Yakovlevich**, was born in 1972. A resident of the city of Sevastopol, he is a businessman. He is sentenced to 6 years of imprisonment in a general-regime penal colony under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was held in custody from 1 October 2020 to 23 March 2021, when he was placed under house arrest. He was taken into custody once again on 22 October 2021.
- 80. Shcherbina, Aleksandr Anatolyevich**, was born in 1976. He resides in the village of Kholmskaya in Krasnodar Krai. He was sentenced to 3 years of imprisonment in a general-regime penal colony under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') of the

Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 6 April 2021.

- 81. Simonenko, Boris Nokolayevich**, was born in 1955. A resident of the town of Kovrov in Vladimir Oblast, he is a pensioner. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 17 February 2021, afterwards he was in custody, but in July 2021 he was placed under house arrest.
- 82. Siyukhov, Inver Ruslanovich**, was born in 1974. A resident of the city of Maykop, he is a businessman. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 16 April 2021.
- 83. Skachidub, Vladimir Yuryevich**, was born in 1961. He resides in the village of Pavlovskaya in Krasnodar Krai. He was sentenced to 4 years and 2 months of imprisonment in a general-regime penal colony under Article 282.2, Part 1.1 ('Recruiting others to take part in the activities of an extremist organisation') and Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') of the Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 11 October 2021.
- 84. Skudayev, Sergei Vladimirovich**, was born in 1978. He resides in the city of Kurgan. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 14 July 2021.
- 85. Solnechny, Aleksei Nikolayevich**, was born in 1976. He resides in the city of Irkutsk. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 4 October 2021, he has been held in custody ever since.
- 86. Stashevsky, Viktor Vladimirovich**, was born in 1966. He resides in the city of Sevastopol. He is sentenced to 6 years and 6 months of imprisonment in a general-regime penal colony under Article 282.2, Part 1 ('Organisation of

the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 29 March 2021.

- 87. Stupnikov, Andrei Garafetanovich**, was born on 17 September 1973. A resident of the city of Krasnoyarsk, he is sentenced to 6 years of imprisonment in a general-regime penal colony under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was in custody from 4 July 2018 to February 2019, when he was placed under house arrest. On 2 July 2019 he was released under a ban on certain activities. He was taken into custody once again on 3 June 2021.
- 88. Suvorov, Danil Sergeyevich**, was born in 1995. A resident of the city of Sochi in Krasnodar Krai, he is charged with committing a crime under Article 282.2, Part 1.1 ('Recruiting others to take part in the activities of an extremist organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 18 August 2021. Since 19 August 2021, he has been held in custody.
- 89. Sviridov, Eduard Vyacheslavovich**, was born in 1964. He resides in the city of Moscow. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 25 August 2021. Since 27 August 2021, he has been held in custody.
- 90. Temirbulatov, Yuri Rafikovich**, was born in 1977. He resides in the city of Moscow. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 10 February 2021.
- 91. Terebilov, Dmitry Sergeyevich**, was born in 1980. He resides in the city of Kostroma. He was sentenced to 3 years of imprisonment in a strict-regime penal colony under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') of the Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 6 September 2021.
- 92. Tolmachyov, Andrei Vladimirovich**, was born in 1975. He resides in the city of Irkutsk. He is charged with committing a crime under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') of the

Russian Criminal Code for her membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 4 October 2021. He has been held in custody ever since.

- 93. Tolokonnikov, Sergei**, is a 49-year-old resident of the city of Moscow. He is charged with committing a crime under Article 282.2, Part 1.1 ('Recruiting others to take part in the activities of an extremist organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 20 October 2021. He has been held in custody since 22 October 2021.
- 94. Urazbakhtin, Ildar Ismailovich**, was born in 1963. A resident of the town of Kodinsk in Krasnoyarsk Krai, he is a technical inspector. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 20 July 2021. He has been held under house arrest since 21 July 2021.
- 95. Usanov, Yuri Aleksandrovich**, was born in 1991. A resident of the town of Tayga in Kemerovo Oblast, he worked as a construction worker. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He has been held in custody since 2 April 2021.
- 96. Vasilyev, Sergei Yevgenyevich**, was born in 1951. He resides in the city of Irkutsk. He is charged with committing a crime under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') of the Russian Criminal Code for her membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 4 October 2021. He has been held under house arrest ever since.
- 97. Velizhanina, Tatiana Yuryevna**, was born in 1972. A resident of the city of Sochi in Krasnodar Krai, she is charged with committing a crime under Article 282.2, Part 1.1 ('Recruiting others to take part in the activities of an extremist organisation') for her membership in a community of Jehovah's Witnesses, a religious group banned in Russia. She has been held in custody since 24 March 2021.
- 98. Vladimirova, Valentina Ivanovna**, was born on 1956. A resident of the city of Smolensk. She is charged with committing a crime under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for

her membership in a community of Jehovah's Witnesses, a religious group banned in Russia. She was held in custody from 16 May to 22 November 2019, when she was placed under house arrest.

- 99. Vlasov, Andrei Valeryevich**, was born in 1968. A resident of the town of Prokopyevsk of Kemerovo Oblast, he is a photographer. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 12 July 2020. On 14 July 2020, he was placed under house arrest.
- 100. Yagovitov, Boris Yuryevich**, was born in 1972. A resident of the village of Solnechny in Khabarovsk Krai. He is charged with committing crimes under Article 282.2, Part 2 ('Participation in the activities of a banned religious organisation') and Article 282.3, Part 1 ('Financing extremist activities') of the Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 5 June 2021. He has been held under house arrest since 7 June 2021.
- 101. Yegozaryan, Igor Artyomovich**, was born in 1965. A resident of the city of Volgograd, he is a worker. He was sentenced to 6 years of imprisonment in a general-regime penal colony under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') of the Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was held in custody from 16 May to 26 December 2019, when he was released under a ban on certain activities. On 23 September 2021, he was taken into custody once again.
- 102. Zakaryan, Vardan Pegatosovich**, was born in 1971. A resident of the city of Moscow, he is a tailor. He is charged with committing crimes under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') and Article 282.3, Part 1 ('Financing extremist activities') of the Russian Criminal Code for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 24 November 2020. During his detention, he was beaten and subject to psychological pressure. On 30 November 2020, he was placed under house arrest.
- 103. Zhiltsov, Pyotr Alekseyevich**, was born in 1987. He resides in the city of Yalta in Crimea. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was detained on 29 July 2021. On 30 July 2021, he was placed under house arrest.

**104. Zhukov, Yevgeny Sergeevich**, was born in 1969. A resident of the city of Sevastopol, he is a construction worker. He is charged under Article 282.2, Part 1 ('Organisation of the activities of a banned religious organisation') for his membership in a community of Jehovah's Witnesses, a religious group banned in Russia. He was held in custody from 1 October 2020 to 17 May 2021, when he was placed under house arrest.
